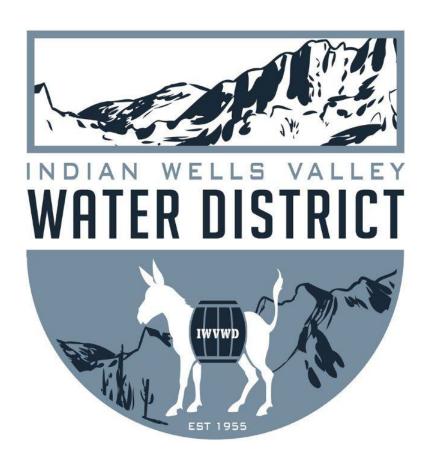

RESOLUTION NO. 22-17

RESOLUTION OF THE BOARD OF DIRECTORS OF THE INDIAN WELLS VALLEY WATER DISTRICT, KERN AND SAN BERNARDINO COUNTIES, CALIFORNIA, FOR AN EXCEPTION TO THE CALPERS 180-DAY WAIT PERIOD AND TO APPROVE AN EMPLOYMENT CONTRACT WITH DONALD ZDEBA TO SERVE AS INTERIM GENERAL MANAGER

WHEREAS, the Indian Wells Valley Water District ("District") is a County water district formed pursuant to Division 12 of the California Water Code (Cal. Wat. Code §§ 30000, et seq.); and

WHEREAS, in compliance with Government (Gov.) Code section 7522.56 of the Public Employees' Retirement Law, the District must provide CalPERS this certification Resolution when hiring a retiree before 180 days has passed since their retirement date; and

WHEREAS, Don Zdeba (CalPERS ID - 3785419182) will retire from the District in the position of General Manager, effective December 31, 2022; and

WHEREAS, District had hired a new General Manager to replace Zdeba but the candidate withdrew the acceptance; and

WHEREAS, as of January 1, 2023, The District will not have a General Manager

WHEREAS, Gov. Code section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is July 1, 2023 without this certification Resolution; and

WHEREAS, Gov. Code section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive; and

WHEREAS, the Board of Directors, the DISTRICT and Don Zdeba certify that Don Zdeba has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, an appointment under Gov. Code section 21221(h) requires the retiree is appointed into the interim appointment during recruitment for a permanent appointment; and

WHEREAS, the District has retained a consulting firm authorized the search for a permanent appointment on November 30, 2022; and

WHEREAS, the DISTRICT hereby appoints Don Zdeba as an interim appointment retired annuitant to the vacant position of General Manager for the District under Gov. Code section 21221(h), effective January 1, 2023; and

WHEREAS, this Gov. Code section 21221(h) appointment shall only be made once and therefore will end on September 30, 2023: and

WHEREAS, the entire employment agreement and/or contract between Don Zdeba and the District has been reviewed by this Board of Directors and is attached herein as Exhibit "A"; and

WHEREAS, no matters, issues, terms or conditions related to this employment and appointment have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be limited to 960 hours per fiscal year (July 1 through June 30) for all CalPERS employers; and

WHEREAS, the compensation paid to Don Zdeba cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal hourly rate; and

WHEREAS, the maximum base salary for this position is \$22,916.17 per month and the hourly equivalent is \$132.21 per hour, and the minimum base salary for this position is \$16,666.66 per month and the hourly equivalent is \$96.15 per hour; and

WHEREAS, Don Zdeba will RECEIVE a monthly salary of \$22,916.17 which equates to \$132.21 per hour; and

WHEREAS, Don Zdeba has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate; and

THEREFORE, BE IT RESOLVED THAT the DISTRICT hereby certifies the nature of the employment of Don Zdeba as described herein and detailed in the attached employment agreement/contract and that this appointment is necessary to fill the critically needed position of General Manager for the District by January 1, 2023, because Don Zdeba is retiring effective December 31, 2022, and the candidate hired to replace Don Zdeba withdrew after accepting the job.
