#### TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:

PLEASE TAKE NOTICE that on March 22, 2024, at 1:30 p.m., the Court held (a) a hearing on the Motion for Order to Divide Trial into Phases, Issue an Order to Show Cause re: Basin Boundary, Set a Phase 1 Trial re: Groundwater in Storage and United States' Federal Reserved Water Right Claim, and Partially Lift Discovery Stay ("Phase 1 Trial Motion") of Defendant, Cross-Complainant, and Cross-Defendant Indian Wells Valley Water District ("District") in the above-captioned action; and (b) a Status Conference in the above-captioned action and all related actions. The Court made the following rulings:

#### 1. In Case No. 30-2021-01187275-CU-OR-CJC:

- A. Ruling on the Phase 1 Trial Motion: The Court GRANTED in part and DENIED without prejudice in part the Phase 1 Trial Motion. The Court granted the Phase 1 Trial Motion as to the District's request to set a phase 1 bench trial ("Phase 1 Trial") to adjudicate the federal reserved water right claim of Cross-Defendant United States of America. The Court denied without prejudice the Phase 1 Trial Motion as to the District's request to set trial to determine the amount of groundwater in storage within the Indian Wells Valley Groundwater Basin ("Basin"). The Court further granted the Phase 1 Trial Motion as to the District's request to partially lift the stay on discovery as to initial disclosures per Code of Civil Procedure section 842, as to the District's request to partially lift the stay on discovery as to the issue to be tried at the Phase 1 Trial, and as to the District's request to partially lift the stay on expert disclosures as to the issue to be tried at the Phase 1 Trial.
- B. <u>Phase 1 Trial</u>: The Court set the Phase 1 Trial with a ten-court-day estimate for **April 28, 2025, at 9:00 a.m., in Department CX101** of the Orange County Superior Court, Civil Complex Center, located at 751 West Santa Ana Boulevard, Santa Ana, California 92701. The Court ordered that the United States' federal reserved water right claim will be tried at the Phase 1 Trial.
- C. <u>Pre-Trial Schedule for the Phase 1 Trial</u>: The Court ordered the parties to meet and confer to develop a pre-trial schedule, including a schedule for discovery, the exchange of expert disclosures, expert discovery, the filing and service of dispositive motions (if any), and

the filing and service of motions in limine (if any), among other things, for the Phase 1 Trial.

The Court further ordered the District to submit a proposed Case Management Order for the Phase 1 Trial based on the parties' meet and confer efforts.

- D. <u>Exchange of Initial Disclosures</u>: The Court ordered the exchange of initial disclosures required by Code of Civil Procedure section 842 to occur no later than **May 17, 2024** for all parties who had already appeared in the case as of the March 22, 2024 Status Conference. For any party making its first appearance in the case after March 22, 2024, the Court ordered that the party shall exchange its initial disclosures **within 60 days from the date of that party's appearance**.
- E. <u>Proof of Service and Notice</u>: The Court ordered the District to file and serve proof of service and notice with supporting declarations and documentation for all methods of service and notice, including the District's recent posting and prior certified mailing, no later than **April 5, 2024**.
- F. The Court ordered the District to prepare a Proposed Order to Show Cause to submit to the Court no later than **March 29, 2024**.
- G.
