<u>Background:</u> The Department of Water Resources (DWR) offers Facilitation Support Services (FSS) to help GSAs and local water management groups foster discussions among diverse water management interests and jurisdictions in support of Sustainable Groundwater Management Act (SGMA) implementation. Through the FSS Program, the Indian Wells Valley Water District (IWVWD) requested professional facilitation to support the basin in discussing challenges related to SGMA, the Indian Wells Valley Groundwater Sustainability Plan (GSP), and the multiple related lawsuits that have been filed, and to assist the community to understand and clarify the issues being faced in order to help discussions focus on constructive solutions moving forward.
