Declarations of Candidacy for eligible candidates desiring to file may be obtained from the Elections Division, 1115 Truxtun Avenue, Bakersfield, commencing on July 13, 2020, 113 days before the election, and shall be filed with the Elections Division no later than 5:00 p.m., August 7, 2020, the 88th day before the election.

Current law requires all candidates to file a Statement of Economic Interest (Form 700) with the county elections division where they file their declaration of candidacy. These forms are due no later than the final filing date for the declaration of candidacy. The form can be found on the FPPC website (www.fppc.ca.gov) or is available at the Elections Division. To obtain information regarding filing, call the Elections Division (661) 868-3590 or visit our website for the Candidate Handbook at <http://www.kernvote.com>.

In the event there are no nominees or an insufficient number of nominees for each office and a petition for an election is not timely filed, an appointment to such office shall be made pursuant to Elections Code Section 10515.

Each candidate filing for a nonpartisan elective office may prepare a Candidate's Statement pursuant to Section 13307 of the Elections Code. Such statements may include the name, age, and occupation of the candidate and a brief description of no more than 200 words of the candidate's education and qualifications expressed by the candidate. Each statement shall be included in the Sample Ballot, which is mailed to each voter.

Each candidate filing a statement will be required to pay in advance their pro rata share as a condition of having their statement included in the Sample Ballot.

En el caso de que no haya nominados o un número insuficiente de nominados para cada cargo y una petición para una elección no se presenta de manera oportuna, un nombramiento para tal cargo se hará conforme al Código Electoral Sección 10515.

Cada candidato que se presenta para un cargo electivo no partidista puede preparar una Declaración del Candidato conforme a la Sección 13307 del Código Electoral. Tales declaraciones pueden incluir el nombre, la edad, y la ocupación del candidato y una breve descripción de no más de 200 palabras de la educación y las cualificaciones del candidato expresadas por el candidato. Cada declaración se incluirá en la Muestra de Boleta, que se envía por correo a cada votante.

Se requerirá que cada candidato presentando una declaración pague por adelantado su parte prorrateada como condición de tener su declaración incluida en la Muestra de Boleta.
